Mike's law practice emphasizes land use, regulatory, environmental, civil rights and tort-related claims and issues in defense of towns, cities, counties and other government entities. He has over 24 years of litigation experience before quasi-judicial tribunals, administrative agencies, state and federal trial courts and state and federal appellate courts. He has argued dozens of appeals, including a 2003 Ninth Circuit decision affirming dismissal of \$5 million 1983 claims against local government elected officials and awarding them over \$100,000 in attorneys' fees. Mike has written numerous articles on municipal, land use and civil rights issues, as well as government risk management.

He is a frequent speaker at conferences on topics ranging from general municipal and government law, land use, civil rights liability to quasi-judicial decision-making, parks and recreation liability and general risk management for government officials.

He also provides training to elected officials and government employees.
